Collection Development Plan Conspectus Analysis

Introduction

A conspectus of the PHCC library collection was performed in the fall of 2016. The process consisted of an examination of the library's collection from a broad to a narrow focus. The broad categories are Humanities (100,200,400,700,800), Social Sciences (300,900), and Natural Sciences (000,500,600.) The narrow focus looked at each of the Dewey classes. A collection plan has been developed that links the purchase of materials to the budget process and to providing the users of the library access to a well-rounded collection.

Library mission

The Pennsylvania Highlands Community College (PHCC) Library is dedicated to providing its users with access to informational resources designed to enrich and support the educational objectives of the Pennsylvania Highlands Community College.

The PHCC Library will provide resources in a variety of formats that will be designed to allow for universal access by all types of users.

The PHCC Library will provide the technology necessary to make its users literate and knowledgeable of information retrieval techniques and will encourage lifelong learning through information literacy instruction, technology skills training, and individualized instruction.

The PHCC Library will strive to be an active member of the community it serves and to support reading and literacy initiatives and to work with organizations and programs that promote literacy and love of reading.

The PHCC Library will strive to remain in the forefront of the information revolution through continued staff and faculty development and training. Only through continued expansion and growth will the PHCC Library be able to meet the informational needs of its users today and tomorrow.

<u>Analysis</u>

A snapshot of the collection shows that the average copyright date for the collection is 2001. The total library collection is 13,472 titles with 14,177 copies (11/09/16). Electronic access to materials will be discussed in a separate section later.

Broad Focus

The broad focus looks at the collection in the terms of Humanities, Social Sciences, and Natural Sciences

The following table illustrates the number of titles in each division and the average publication date.

Since 2006, the library budget for books has been experiencing a steady decline with sporadic spikes in increases. In 2013, \$10,000 was moved from the book budget to create an e-book budget for the purchase of electronic books.

Review of this document occurs annually during the fall semester and before the mid-year budget revision takes place.
